It appearing that effective midnight, July 2, 1969, a vacancy will exist in the office of the District Superintendent of Schools of the Sole Supervisory District of Chenango, Madison and Otsego Counties; and

It further appearing, after a survey of the field in the counties of Chenango, Madison, Otsego, Delaware and Otsego Counties that the educational interests of the above counties will be more adequately served by the reorganization of supervisory districts in said counties, hereinafter set forth,

NOW, THEREFORE, pursuant to section 2201 of the Education Law,

IT IS HEREBY ORDERED that the Sole Supervisory District of Chenango, Madison and Otsego Counties and the Sole Supervisory District of Delaware, Chenango and Otsego Counties, be reorganized as one supervisory district to be known as the Sole Supervisory District of Delaware, Chenango, Madison and Otsego Counties.

As so reorganized the above named supervisory district shall be constituted as follows:

SOLE SUPERVISORY DISTRICT OF DELAWARE, CHENANGO,
MADISON AND OTSEGO COUNTIES

Towns of Bovina, Colchester, Delhi, Franklin, Hamden, Hancock, Masonville, Meredith, Sidney, Tompkins and Walton, Delaware County; Afton, Bainbridge, Columbus, Coventry, German, Greene, Guilford, Lincklaen, McDonough, New Berlin, North Norwich, Norwich, Otselic, Oxford, Pharsalia, Pitcher, Plymouth, Preston, Sherburne, Smithville and Smyrna, Chenango County; Georgetown, Madison County; Butternuts, Otego and Unadilla, Otsego County.

It is further ORDERED that the Board of Cooperative Educational Services for the Sole Supervisory District of Chenango, Madison and Otsego Counties and the Board of Cooperative Educational Services for the Sole Supervisory District of Delaware, Chenango and Otsego Counties are hereby constituted as a single Board of Cooperative Educational Services pursuant to section 1958, subdivision 7, of the Education Law and such board is hereby redesignated to be the Board of Cooperative Educational Services for the Sole Supervisory District of Delaware, Chenango, Madison and Otsego Counties.

This order shall take effect July 3, 1969.
